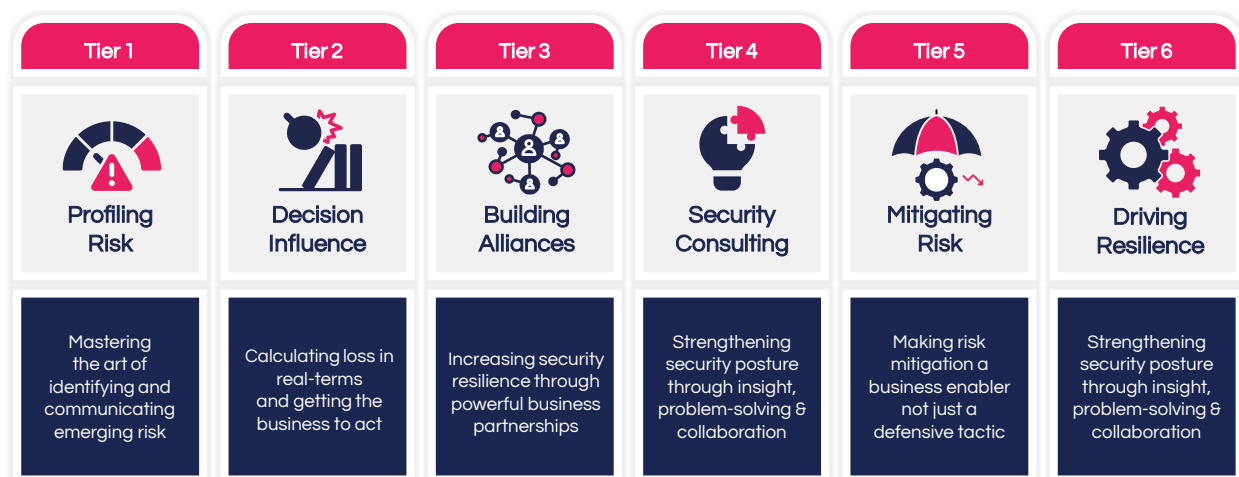

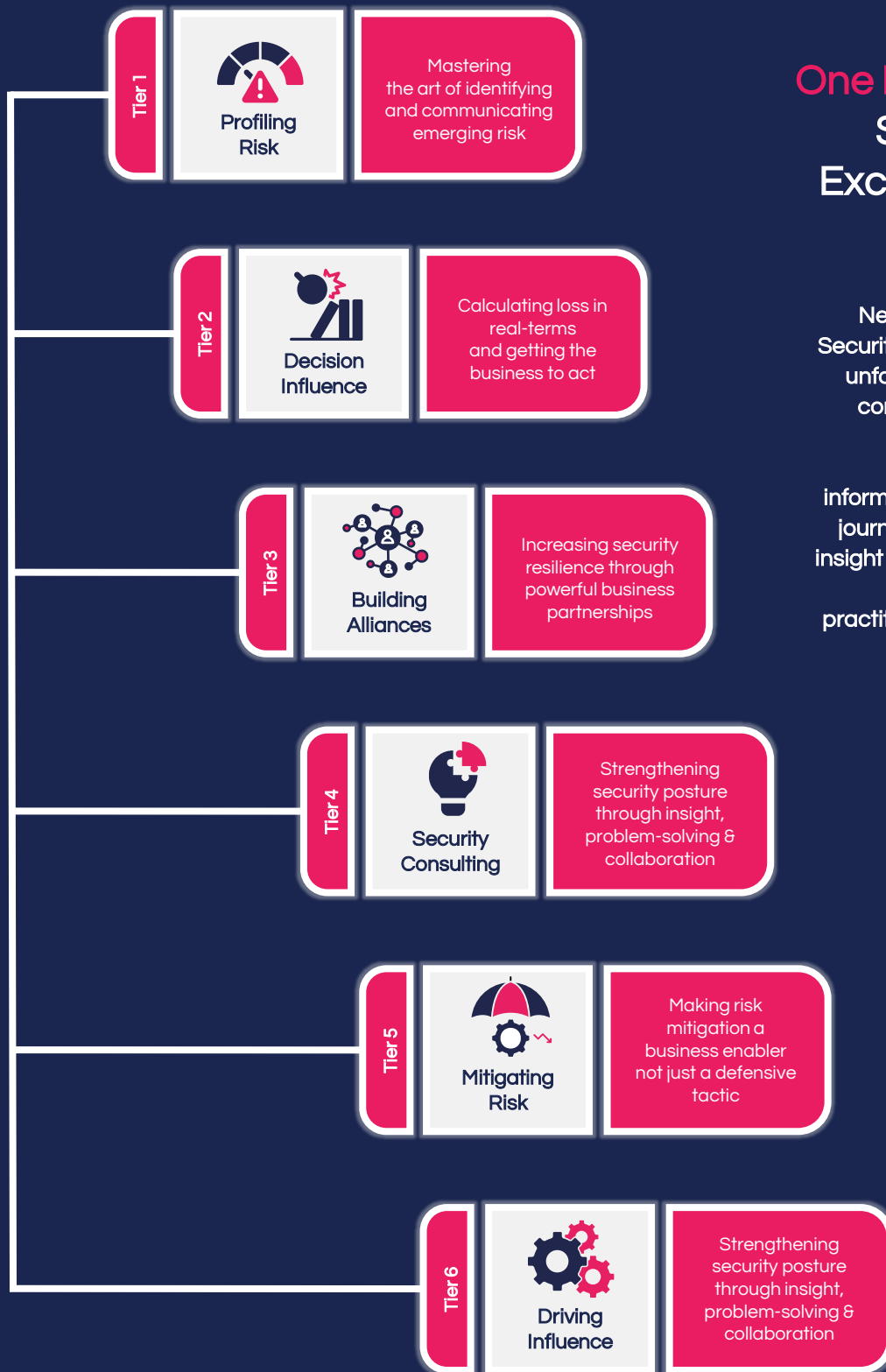

Identifying emerging security risk across the corporate environment is a critical task faced by InfoSec teams.

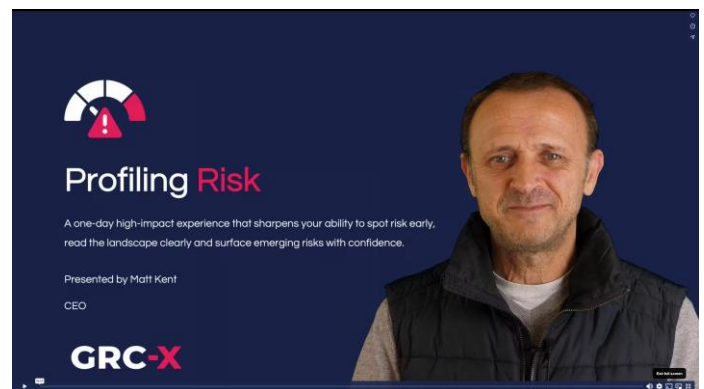
An even tougher challenge is bringing it to light and getting the most important people in the room to listen.

Influencing security decisions is one of the hardest parts of the practitioner role. Even strong evidence fails without the skills to turn insight into commitment.

Decision-makers are shaped by bias, pressure and competing priorities. Good escalations fall flat when emotion, misunderstanding or poor framing get in the way. Pushback stalls conversations and delays action when the ask isn't clear or credible.

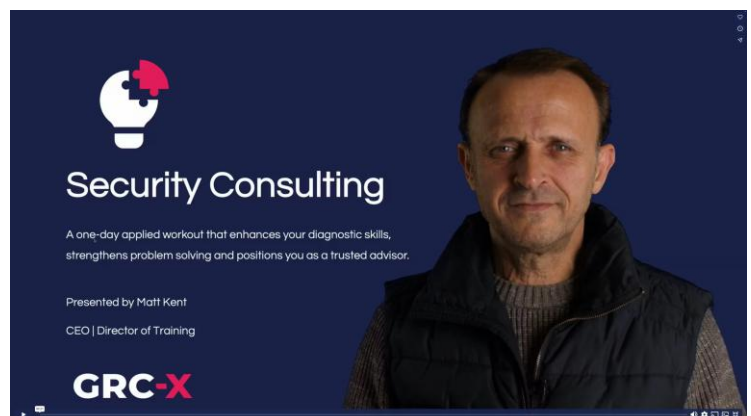
